“SECOND: Insofar as may be allowed or permitted under the existing laws directly or indirectly as principal, agent, commercial broker or contractor, to carry on the business of providing and rendering general services incidental to and necessarily connected with the operation and management of port terminals within the Philippines or overseas, which will involve the handling of containers, bulk liquid and dry cargoes, refrigerated warehousing facilities, warehousing and stevedoring, lightering, towing and/or storing of cargo handled by the company to and from port terminals in the delivery from abroad and/or for shipment abroad as maybe necessary or incidental thereto.”

“THIRD: That the place where the principal office of the corporation is to be located is at ATI Head Office, A. Bonifacio Drive, Port Area, Manila”
